# HEA 1001 – State Budget

\$45 Billion in spending priorities for the state

Behavior Health in SEA 1 Crider at \$100 Million (\$50/\$50)

Public Health in SEA 4 Charbonneau at \$225 (\$75/\$150) Million

\$500 million General Fund appropriation over the biennium for Collaborative Communities or READI 2.0

# HEA 1001 – State Budget

Next Level Trails \$30 Million (DNR)

Broadband Grants \$250 Million (Lt Gov)

\$10 Million for Public Safety Regional Mental Health Facility grants for capital projects

Funds the Residential Housing Infrastructure Assistance Program (HB 1005) (expected to generate \$3.2B in low interest loans over 25 years)



# HEA 1001 – State Budget

Funding Indiana's roads for a stronger, safer tomorrow task force established (FIRSST)

Extends the Fuel Tax Indexing gasoline tax and the special fuel tax rates through 2028. This provision could increase local revenue by approximately \$19 M per year

*HEA 1050 extends the alternative fuel vehicle fee indexing*

# HEA 1001 – State Budget

Increases cost of SBOA audits to 50% of actual cost (\$400 daily cap)

Ties Dep. Prosecutor salary to 70% of Prosecutor

Opioid Litigation Funds distributed 2 x Yr., (any unit distributions below \$5000 roll up to count)

# HEA 1005 – Housing

## HEA 1005

Creates state revolving loan fund with the Indiana Finance Authority IFA to pay for costs of infrastructure related to house development

70% of the fund for counties under 50K population

Removes 1% housing stock requirement to establish Housing TIF for 4 years

# HEA 1167 Live Streaming and Archiving meetings

HEA 1167 Live Streaming and Archiving meetings Smaltz.  
Beginning July 1, 2025

Requires state and local agencies to provide,

- (1) live transmissions of public meetings; and
- (2) archive of copies of the live transmissions with links to any meeting agendas, minutes, or memoranda.

Executive, Legislative, or Fiscal body and any governing body that conducts regular meetings in the same room.

# Behavior Health

## SEA 1 Mental Health Services, Crider

\$100 Million (\$50/\$50) in the state budget

According to the Indiana Behavioral Health Commission :

- 1 in 5 Hoosiers live with a mental health illness
- Untreated mental illness in Indiana cost \$4.2 billion annually

# Behavior Health

## SEA 1 Mental Health Services, Crider

Shifts delivery model for mental health services to Community Behavioral Health Clinics (CCBHC) rather than Community Mental Health Centers (CMHC) to increase access and availability to quality care.

Expand new 988 Suicide and Crisis Lifeline so that Hoosiers have **someone to call, someone to respond** and **somewhere to go** in an emergency.

# Behavior Health

HEA 1454 Dept of Local Government Finance

“Christmas Tree Bill” 282 pgs (Budget 263)

Authorizes each county to opt into representation on the board of the CMHC assigned to the county, with maximum of 3 counties

# HEA 1454

## HEA 1454 Dept of Local Government Finance

Authorizes up to .3% Jail/Rehab Facility LIT for counties with current bonds and allows any county to use up to .2% for operating costs

Authorizes all counties to adopt up to .2% LIT for EMS

Adopting LIT body can authorize up to .05% for TWP FD, VFD, Fire District or Fire Territory based on non land AV

Authorizes TIF to be spent on police and fire operating costs

Requires any change to LIT rate that impacts another unit must be done by August 1 with notice within 15 days



# Behavior Health

## HEA 1006 Mental Health Programs Steuerwald

- Involuntarily Immediate & Emergency Detention
- Alternative to incarceration for mental health services
- Commitment to treatment is medically necessary

*Partners are working to set SOPs and care coordination for CITs or Crisis Intervention Teams*

*JRAC, DOC, CMHC, Hospitals, NOMI*

# Behavior Health

## HEA 1006 Mental Health Programs Steuerwald

NOMI assisting community CITs with 1 ½ day workshops, at the request of the local JRAC, to identify priorities/needs.

Workshop topics:

Involuntary Detention laws; Mental Illness 101; Verbal De-escalation Techniques; Suicide Prevention; and more.
